AMOUNTS TO USE:

WITH HERBICIDES: 2.5 - 5 oz. per acre or 2.5 - 5 oz. per 10 - 40 gal. spray solution depending on herbicide use.

WITH INSECTICIDES AND FUNGICIDES: 2.5 - 5 oz. per 100 gal. spray solution

MIX DIRECTIONS FOR USE WITH HERBICIDES, INSECTICIDES AND FUNGICIDES:

Before mixing, read all pesticide labels for specific mixing instructions and caution statements. A compatibility test is recommended when mixing chemicals for the first time.

- 1. Add the water to the spray tank and turn on the agitator or recirculation pump.
- 2. Add **APSA-80** to the tank and allow it to mix until dispersed thoroughly.
- 3. Add the herbicides, insecticides or fungicides that are to be used according to the manufacturer's instructions.

If frozen, return to room temperature and mix thoroughly.
